BY-LAWS COMMITTEE

The last three changes to the By-Laws have been:

May 2015 – The Bill Trimble Service Award was added to the Article XII – Awards.

October 2012 – Article II – Membership was amended to add the word “full” to cover that only those movers who had a full certificate of exemption and not a probationary certificate were eligible for membership.

SECTION 1. Members of the corporation shall be in three categories; namely, members, branch members, and associate members. To qualify as a member, any person, partnership or corporation operating with a valid **full** certificate of exemption to engage in shipping of Group 18-A household goods within the state, issued by the N.C. Utilities Commission, may be eligible for membership in the corporation subject to additional criteria, including but not limited to, financial solvency, fitness of moral and ethical character, and other criteria as adopted and approved by the Board from time to time.

April 2012 – Article III, Directors was amended to change the definition of a quorum.

SECTION 4. A quorum for the transaction of business at any regular or special meeting of the directors shall consist of ***those board members present.***

The following actions have been happened since the last board meeting:

Discount Movers of Greensboro - Bryan Jones of Steele & Vaughn lost a move to this illegal carrier. Discount Movers had authority several years ago and got of the business. Bryan turned them into Cynthia. Since he knew when and where the move was taking place, Cynthia gave the Highway Patrol the information. He was stopped and fined \$1,000 by the Highway Patrol. Promptly called Nick Jeffries and Cynthia, begging him to do something about the citation - which they can't. He is applying for a certificate.

Docket T-4588 Sub 1 - Carolina Pack N Load - this is an illegal company that the Public Staff requested a Show Cause Hearing from the Commission because they continued to operate as an illegal company. Hearing was held on December 15. Public Staff recommend that they be fined \$5,000, only be granted a Probationary Certificate until they paid the fine, resolved their outstanding complaints and don't do any more illegal moves. This guy testified that he had done 250 moves in the past year. The Commission has not ruled yet.

Docket T-4580 Sub 0 - South Park Ballantyne Moving - this application was protested and went to hearing on 2/4. Ken Scallions originally owned Ballantyne and Beyond Moving. He sold it last year. He was trying to get another certificate; the company he sold to protested the application due to breach of contract. No ruling from the Commission yet.

Several illegal moving companies have been turned into the Public Staff.

If you know of an illegal move taking place, you can turn the company into the Highway Patrol. Dial *HP and ask to speak to someone in the Motor Carriers Division

Next meeting with Commissioner Beatty is scheduled for April 7.

FYI, I have also attached the spread sheet that I keep on my computer showing all docket information from the Commission and the action taken. It's the only way I can keep up with everything!

Report to the Board – Military


Due to isolated access incidents affecting a few rate filers, SDDC extended Round 1 for rate filing until 6:00 p.m. cst on 20 Jan and adjusted Round 2 to go from 6:00 p.m. 3 Feb to 6:00 p.m. cst on 10 February

The REAL ID Act may have a real impact on your ability to go on military bases. If you or your drivers have driver's licenses from Illinois, Minnesota, New Mexico, Missouri, or Washington, as of 10 January, these States no longer meet the standards set forth in the act that established minimum federal security standards. On 10 October 2016, there are an additional 22 states (including North Carolina) which will have their current extension expire.

On 16 December 2015, SDDC announced that the HHG Channeling Concept Pilot Program will not begin in the spring of 2016 as previously planned. No decisions have been made or announced about whether or not the pilot program will proceed at all.

A DPS change which alleviated the additional work imposed on the PPSO when a shipment is refused by awarding the shipment to the next TSP was inadvertently tested in December when DPS access issues prevented TSPs from accepting shipments in a timely manner. It apparently works since shipments which were not responded to within 24 hours were automatically awarded to the next TSP. Maybe there is some hope that shipment refusals will be allowed in 2016.

EXECUTIVE DIRECTOR'S REPORT

Tariff training seminars will continue to be held on a regular basis. We are still getting very good attendance at these seminars. They continue to be the best recruiting ground for new members. We just held one in Raleigh this past week with over 20 attendees. Next seminar will be March 16 in Concord.

The Convention issue of the Tar Heel Van has been published. Next issue will be published in early March.

I continue to send updates out to the membership 1-2 times a month to notify them of happenings that are more time sensitive.

I will be attending AMSA's board meeting and annual convention March 20-23 in New Orleans. Any suggestions regarding educational offerings or anything else you want communicated to them, just let me know.

Forms are still going strong. We sold \$50,041 last year, after selling \$57,191 in 2014. January forms orders were \$5,200.

Annual dues invoices have gone out. We have already gotten payment from about half the membership. Associate dues only went out this past week, since they get hard copies mailed to them.

The tariff rate for labor is \$31.40 an hour.

We would have to use James Thornton to file this for us. However, he has told me that if I have it ready and all he has to do is sign the form, he will not charge us for this. I have recommended him to several people who needed a lawyer for getting their certificate and he is very appreciative.
