Report to the Board - Military

USTRANSCOM announced a recalculation of Customer Satisfaction Survey Scores (CSS) for the 1 Jan – 14 May 2018 performance period. The data pull for this recalculation was 1 Nov 2016 to 31 Oct 2017 and is effective 1 Jan 2018. TSPs that are not statistically valid will receive the number of supplemental scores needed to achieve validity. The value attributed to supplemental scores is equal to the average value of the market and are calculated each performance period. Average scores this period = dHHG 85.95; iHHG 84.04; iUB 87.18 and OTO 81.51.

2018 Rate Filing Schedule began with Round 1 opening 15 Jan and closing 22 Jan. Round 2 dates are 11 Feb thru 16 Feb.

USTRANSCOM has awarded a separate development contract for the development of a new prototype to replace the current DPS computer system. Indications are that the new system would be based on the existing business rules rather than a new program design. Representatives from the new contractor visited the Fort Bragg area 10-12 Jan seeking input. Before we all get excited about this project, remember it is only a new computer system that is supposed to fix/replace a system that has been broken since day 1. At least they are seeking our input and have even listened to our suggestions that any new system must include an application for two way interface. COL Lounsbrough has been invited to speak at AMSA's annual conference in April where it is hoped he will provide new details on the prototype system.

Fort Bragg has announced that the implementation date for REAL ID will begin on 22 Jan. Those without a REAL ID will need additional documents to obtain a visitor pass to Ft Bragg. Those documents can include a US passport, permanent resident card, foreign passport with temporary I-551 stamp, or a

Native American tribal document, among other forms of ID. Visitors with a current pass to access Ft Bragg may continue using that pass until it expires.

Docket T-100 Sub 49 – On January 1, 2018, the 1.8% annual rate increase took effect.

Docket T-100 Sub 49 – The NCMA filed amendments to the Maximum Rate Tariff requesting that the carriers be able to pass through their credit card processing fees and adding Flat Screen TV to the packing and container charges. The Commission requested that comments be filed by February 9, with reply comments due February 23. If you haven't filed comments yet, please do so. Ask Pam for how to file them. So far only four comments have been filed to the docket, but we know that more than that has been filed. They haven't been processed due to the holiday on Monday and the snow on Wednesday-Friday.
